Provided proper handling and storage, Haltanol supplied by **Monument Chemical** is expected to be technically stable for 12 months after production date

Exclusion statements:

With respect to the manufacturing process and controlled handling, we exclude to the best of our knowledge the presence in Haltanol supplied by Monument Chemical BVBA of:

- any Genetically Modified Organism (GMO) origin based material, nor Bovine Spongiform Encephalopathy (BSE) nor Transmissible Spongiform Encephalopathy (TSE); nor Melamine. No material derived from plants or animals is used as raw materials, processing aids or additives. No material from animal origin is processed on the equipment which is used for the production of the product
- the presence of heavy metals in our manufactured product; so also no conflict Minerals (3TG: Tean, Tantalum, Tungsten and Gold).
- any Phthalates, Bisphenol A, Glycols or Formols; formaldehydes
- any Allergens, Toxic, potent, antibiotic, pesticides
- any Plasticizers or other material contaminated with phthalates (DEHP, DIDP, DINP, ...)
- any Nitrosamine, Furfural, 2-Chloracetamid
- any Chlorinated, Brominated organic and Tin compounds
- any preservatives, additives and residuals impurities
- any irradiation
